Course Description:

Essential elements of spoken language, concepts and principles of phonetics, use of International Phonetic Association (IPA) system of phonetic transcription and practice in speech sound production and identification, analysis of problems of pronunciation

Course Objectives:

1. To have an understanding of the nature of the individual speech sounds and the dynamics of sounds in context
2. To learn to hear, identify and produce a sound or sound contrasts
3. To become aware of the need for distinct articulation
4. To develop the capacity of perceptive listening so that students can recognize correctly articulated speech in themselves and others
5. To be able to use the phonetic knowledge in understanding the phonetic differences found in different languages.

2. hear, identify and produce a sound or sound contrasts,
3. recognize the need for distinct articulation,

Plan: Define the current problem, process, and issue and establish objectives and processes required to deliver the desired results.

Do: Implement the plans and new processes developed.

Check: Monitor and evaluate the implemented process by testing the results against the predetermined objectives.

Act: Apply actions necessary for improvement if the results require changes.

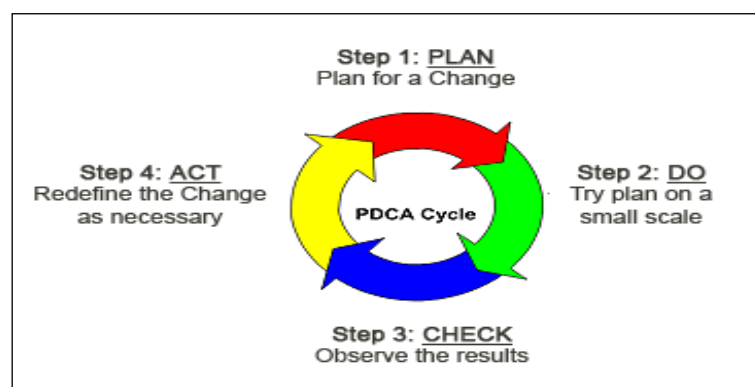


Figure 1: PDCA Cycle (<http://www.swopehealth.org>)
